Esta bibliografía incluye trabajos recientes publicados sobre diversos aspectos del profesorado. Las subdivisiones de esta bibliografía reproducen las utilizadas por Higher Education Abstracts. Para la búsqueda se utilizaron los números de Higher Education Abstracts publicados en el 1987 (Volumen 22 (2-4); Volumen 23 (1) y los disponibles para el año 1988 (Volumen 23 (2-3). También se hicieron consultas bibliográficas con el Centro de Documentación de la Unión de Universidades de América Latina (UDUAL), con el Centro de Documentación e Investigación Educativa (CEDIE) de la Pontificia Universidad Católica Madre y Maestra y en el Catálogo de Analíticas y en el Catálogo Público de la Biblioteca "Emilio Rodríguez Demorizi" del Instituto Tecnológico de Santo Domingo (INTEC). La preparación de la bibliografía tuvo como objetivo la presentación de algunos trabajos recientes sobre el profesorado; no pretendió ser una bibliografía exhaustiva. De los trabajos reseñados en el Higher Education Abstracts se seleccionaron sólo aquellos publicados.
